SECTION 1: IDENTIFICATION

Recommended use	Cleaning of compatible screens, displays, lenses, and external electronic surfaces.
Restrictions on use	For external surface cleaning use only. Do not use it on skin. Verify surface compatibility before use. Keep away from heat and ignition sources.

SECTION 2: HAZARD(S) IDENTIFICATION

Hazard classification is based on the liquid formulation contained in the wipe and is assessed using the upper end of the stated isopropyl alcohol concentration range (30%).

Classification	Flammable liquid - Category 3; Eye irritation - Category 2A; Specific target organ toxicity, single exposure - Category 3 (narcotic effects)
Signal word	WARNING
Hazard statements	Flammable liquid and vapor. Causes serious eye irritation. May cause drowsiness or dizziness.
Pictograms	Flame; Exclamation mark

- Keep away from heat, sparks, open flames, and hot surfaces. No smoking.
- Avoid breathing vapors.
- Use with adequate ventilation.
- Avoid contact with eyes.
- Keep sealed until use.
- Store in a cool, dry place away from ignition sources.



SECTION 3: COMPOSITION/INFORMATION ON INGREDIENTS

The wipe contains 2 mL nominal total liquid formulation. The formulation is absorbed into the nonwoven substrate; no free liquid should be present in the sealed packet.

The screen-cleaning liquid formulation is water-based and is manufactured within the following composition ranges: 20-30% isopropyl alcohol, 70-80% purified water, and less than 1% proprietary additive(s).

SECTION 4: FIRST-AID MEASURES

Inhalation	Move to fresh air. Seek medical advice if dizziness, headache, coughing, or respiratory discomfort persists.
Skin contact	Wash exposed skin with soap and water if irritation occurs.
Eye contact	Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. Seek medical attention if irritation persists.
Ingestion	Rinse mouth. Do not induce vomiting. Contact a poison center or physician if a significant amount is swallowed or symptoms occur.
Most important symptoms/effects	Eye irritation; dry skin after repeated exposure; dizziness or drowsiness after excessive vapor exposure.
Medical treatment	Treat symptomatically.

SECTION 5: FIRE-FIGHTING MEASURES

Suitable media	Water spray, alcohol-resistant foam, dry chemical, or carbon dioxide.
Specific hazards	The liquid component is flammable. Vapors may form ignitable mixtures with air. Combustion may produce carbon monoxide and carbon dioxide.
Firefighter protection	Use protective equipment appropriate to the fire conditions and cool exposed packages with water spray.



SECTION 6: ACCIDENTAL RELEASE MEASURES

Personal precautions	Remove ignition sources and provide ventilation.
Cleanup	Collect damaged wipes or sachets and place them in a suitable closed container. Absorb any released liquid with inert material.
Environmental precautions	Prevent release to drains and waterways.

SECTION 7: HANDLING AND STORAGE

Handling	Use only as directed. Keep away from heat, sparks, flames, and other ignition sources. Avoid eye contact. Wash hands after handling.
Storage	Wipes are hermetically sealed in foil sachets. Store cool and dry in original packaging, away from direct sunlight, heat, oxidizers, bleach/sodium hypochlorite, and ignition sources.

SECTION 8: EXPOSURE CONTROLS/PERSONAL PROTECTION

Isopropyl alcohol - OSHA PEL	400 ppm TWA
Isopropyl alcohol - ACGIH TLV	200 ppm TWA; 400 ppm STEL
Engineering controls	Normal use of individual wipes generally requires ordinary room ventilation. Provide additional ventilation if many wipes are used in a confined area.
Eye protection	Not normally required for routine wipe use; avoid eye contact. Safety glasses may be appropriate for occupational handling.
Hand protection	Not normally required for brief routine use. Protective gloves may be appropriate for prolonged or repeated occupational exposure.
Respiratory protection	Not normally required for routine use with adequate ventilation.

SECTION 10: STABILITY AND REACTIVITY

Reactivity	May react with strong oxidizers.
Chemical stability	Stable under recommended storage conditions.

Conditions to avoid	Heat, sparks, flames, high temperatures, direct sunlight, and static discharge.
Incompatible materials	Strong oxidizing agents and sodium hypochlorite/bleach.

SECTION 11: TOXICOLOGICAL INFORMATION

Likely routes of exposure	Eye contact, inhalation of vapor, skin contact, ingestion.
Immediate effects	Eye irritation; excessive vapor exposure may cause dizziness or drowsiness.
Delayed/chronic effects	Repeated skin exposure may cause dryness or irritation.
Acute toxicity data	No product-specific acute toxicity testing available. Hazard classification is based on mixture composition and available ingredient information.
Carcinogenicity	Isopropyl alcohol is IARC Group 3 (not classifiable as to carcinogenicity to humans) and is not identified as an OSHA carcinogen.

Ecotoxicity	No product-specific ecological testing available.
Persistence/degradability	Isopropyl alcohol is readily biodegradable.
Bioaccumulation	Low potential for bioaccumulation.
Other effects	Do not discharge wipes or liquid to waterways.

Disposal	Dispose of used wipes, damaged sachets, and unused product in accordance with applicable local requirements. Do not flush.

SECTION 14: TRANSPORT INFORMATION

U.S. DOT: Each individually sealed packet contains 2 mL of liquid formulation absorbed into a solid wipe. When the liquid is completely absorbed, the packet contains no free liquid, and the formulation is Class 3 Packing Group II or III, 49 CFR 172.102 Special Provision 47 provides an exception from the U.S. Hazardous Materials Regulations for sealed packets containing less than 10 mL.
